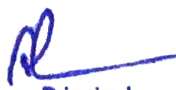

1. The President / V.P. Post can be contested by Students from B. Com./B. A./BCA 5th Semester & M/ Com 3rd Semester (Regular).
2. Students having Backlog cannot apply for any Portfolios.
3. Students who hold any Office once (except for the post of President & V.P.) are not eligible for contesting 2nd term of tenure.
4. General Secretary Posts can 'be contested from B.Com./B.A./BCA/ ITEP 3rd Semester Students Others Portfolios from B.Com./B.A./BCA/ITEP 1st & 3RD Semester Students only.
5. Voting rights Offered to H.S (Arts & Commerce) / B.Com./ B.A./ BCA/ PGDCA/ ITEP/ M.Com. (Regular) classes.
6. Billing / Postering within the college campus are strictly prohibited & liable to face disciplinary action by the Authority.
7. No Outsiders can interfere on any issue of Students Union Election inside the Campus.
8. The Election process will start from the date of Notification.
9. No negative campaigning / vandalism will be tolerated and strict action will be taken against those who are found involving in those activities.
10. 75% attendance is required to contest any portfolio in this Election.
11. The Secretary for Minor Games, Secretary for Debating and Literacy activities, & Secretary for Girls Common Room are reserve for Girls Student.
